Capable, caring adults and young adults play important roles in students' lives and are essential to Operation Overhaul's success. This expectation statement acknowledges the need to provide the safest environments possible for students. By signing this form, adults and young adults agree to conduct themselves responsibly and abide by all expectations as stated below.

1. Adults and young adults are examples for student participants. Being present and actively participating in faith formation activities is vital. Examples include but are not limited to Mass, Reconciliation, Prayer, Adoration, Small Group, etc.
2. Adults and young adults should help foster healthy relationships between students, students and young adults, adults, and those whom we serve.
3. The adult and young adult will enforce all written and signed behavior expectations established for student participation in the event, including but not limited to cell phone usage and dress code.
4. The adult and young adult will not ignore situations involving bullying, hazing, or harassment, nor fail to intervene if students are being threatened, humiliated, or intimidated by other students, adults, or young adults.
5. In the case of inappropriate student behavior, the adult shall bring the issue/concern to a VMY SEMO staff member, such as the Program Coordinator or Director of Operations. The Executive Director will be made aware of all behavior issues by staff and provide direction to staff on an as-needed basis.
6. The adult and young adult will not dispense medication or anything relating to the student's physical or mental health unless specifically directed by the Director of Operations, Executive Director, or Nurses.
7. In an emergency situation, the adult will act in the student's best interest. Seek assistance from Nurses, VMY SEMO Staff, and medical and/or law enforcement personnel as needed. Nurses should be notified immediately.
8. The possession and/or use of illegal drugs is not allowed during the event.
9. The possession and/or use of controlled substances including but not limited to marijuana, morphine, opiates, etc. must be accompanied by a physician's prescription and presented to the Executive Director prior to the event. The organization reserves the right to limit driving privileges, worksite participation, etc. in the interest of participant safety.

10. The possession and/or use of alcohol is not allowed during the event.
11. Using any form of tobacco should be avoided in students' obvious or known presence.
12. As mandated reporters, all concerns regarding abuse must be brought to the attention of the Director of Operations and the Executive Director.
13. Sexual contact of any type with a student is strictly forbidden. All forms of physical contact must be public, appropriate, and non-sexual. Adults and young adults should not initiate physical contact with students including but not limited to hugs, kisses, playful wrestling, braiding hair, etc.
14. Swearing, vulgar, and abusive language is not condoned.
15. Adults will only operate motor vehicles safely and reliably with a valid operator's license and the legally required insurance coverage. Drivers will maintain a speed of 5 miles the posted speed limit to maximize caravan efficiency.
16. Adults and young adults will work to ensure all safety procedures are followed on worksites, including, but not limited to, hydration, safety eyewear, proper ladder usage, preventing unnecessary horseplay, etc.
